9. I, SFC JEFFERY WAYNE LEOPARD, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

From September 2002 until April 2003 I was deployed with 1st Battalion, 20th Special Forces Group (Airborne) for Operation Enduring Freedom. During that time the battalion was operating in Afghanistan with the Forward Operating Base (FOB) located at Karshi-Khanabad Airbase in Uzbekistan. My MTOE position and my primary MOSC at that time was Battalion NBC NCO/74D4S. Soon after our arrival at Karshi-Khanabad, I notified the Support Company NBC NCO (SSG Jon Roth), that we needed to conduct testing for any possible industrial or military contamination in the FOB area. I felt this was a necessary precaution, as the FOB site was located on an old Soviet era military installation. SSG Roth and I used the following equipment to test in and around the FOB site: M8A1 Chemical Alarm Set, Chemical Agent Monitor (CAM), M-256 Detector Kit and a M-272 Water Test Kit. Both the M8A1 Chemical Alarm Set, and the Chemical Agent Monitor (CAM) had predeployment inspections and maintenance performed on them at the Ft Dix, NJ Mobilization Station immediately prior to our deployment and were serviceable. When we conducted tests on 1 OCT, 12 OCT and 18 OCT, we obtained the results listed on exhibit "A" attached to this sworn statement. These results were reported to our Chair of Command. *JWZ*


